1. WHEREAS the MAHARASHTRA AIRPORT DEVELOPMENT COMPANY LIMITED (hereinafter referred to "MADC") is a company incorporated under the Companies Act, 1956 and functions under the superintendence and control of the Government of Maharashtra;

2. AND WHEREAS, Govt. of Maharashtra in Urban Development Department has, in exercise of its power conferred under sub-section (1B) of Section 40 of the Maharashtra Regional and Town Planning Act, 1966 (Mah. XXXVII of 1966) (hereinafter referred to as "the said Act"), vide Government Notification Nos. TPS 1608/2662/CR-111/09/JD-9, dated 28/05/2009; appointed MADC to be the Special Planning Authority for the notified area of Shirdi Airport area at Kakadi Taluka Kopergaon, Dist. Ahmednagar admeasuring 302.80 ha. and comprises area from Kakadi village of Kopergaon Taluka of Ahmednagar, district

3. AND WHEREAS, MADC, had in accordance with sub-section (2) of section 115 as substituted by clause (d) of sub section (3) of section 40 of the said Act carried out survey of the aforesaid notified area and prepared the existing land use map and accordingly prepared the Draft Proposal for the development of land within its jurisdiction;

4. AND WHEREAS, the Board of Directors of MADC, in its 62nd Board meeting held on 28/12/2017, has approved the draft Planning Proposal and Development Control Regulations, for publishing and submitting to the Government after following the due process under the said Act.
